PUBLIC POLICY

One of the objectives of the forestry profession is to assist landowners in making informed decisions about the management of their forests before implementing harvesting activities. With the help of professional forest managers, the goals and objectives of landowners can be blended between the environmental and economic values each woodland is capable of producing.

To that end, and to be able to assist as many landowners seeking professional forestry services as possible, state service foresters will refer to private consulting and industrial foresters those aspects of forest resource management that can support themselves without public assistance.

CONSULTING AND INDUSTRIAL FORESTERS

Private sector foresters are professionals, trained and experienced in forestry, who offer their forest management services to represent the best interests of a prospective client. These services are usually offered on a fee, contract or contingency basis. As with all professional services rendered, it is advisable to enter into a legal service contract or agreement that specifies exactly what is to be done and the results to be obtained from the forester.

This Consulting and Industrial Foresters Referral List is intended as a reference only, not as an endorsement of any forester found herein. The information contained in this publication is updated periodically; it is the responsibility of the users to determine the forester best suited to their particular needs and to contract with that forester.

All foresters practicing within the State of Maryland, public or private, must be licensed. The license requires graduation from a forestry school accredited by the Society of American Foresters with at least a Bachelor of Science degree and two years of practical experience under the guidance of a licensed forester. Foresters on this list are Licensed Professional Foresters with the State of Maryland, Department of Licensing and Regulation, Board of Registration for Professional Foresters.
