Maryland Coronavirus Food Assistance Program I (CFAPI) Bonus Payment Program Details



The Maryland Department of Agriculture (MDA) will issue a bonus payment to Maryland farmers based on a percentage (15%) of federal Coronavirus Food Assistance Program I (CFAPI) funds received for the CFAPI period that ended Sept. 11, 2020.

CFAPI provides vital financial assistance to producers of agricultural commodities who have suffered a 5% or greater price decline or who had losses due to market supply chain disruptions from COVID-19, and face additional significant marketing costs. The commodities covered are: aquaculture (finfish and crayfish), corn, cut flowers, dairy, livestock (excluding poultry), nursery, small grains, soybeans, and specialty crops.

Instructions

Review the steps - Read Carefully.

- 01 | Check your eligibility. Before proceeding with the application, please be sure you are eligible to participate. Eligibility requirements are outlined below.
 - Farmers who received a CFAP1 payment for agricultural commodities in the State of Maryland **are** eligible.
- 02 | Complete the Application.
 - If you meet the eligibility requirements, fill out the application and mail it to the Maryland Department of Agriculture postmarked by **Dec. 1, 2020.**

What Happens After Submission

Read Carefully.

- **01** | MDA will review your mail-in application and either approve or disapprove within 10 working days of it being recieved.
- **02** | If approved, you will receive an email and a check in the mail within approximately 15 days from the approval date. All funds will be dispersed by Dec. 31, 2020.
- 03 | If disapproved, you will receive an email and letter notification.
